49 Degrees North Autumn Mountain Bike Ride  
***TOUR DE ROCK***  
***And Rough Ride 4000'***

Once again, you are invited to join us at 49 Degrees North for a mountain bike ride/fund raiser to benefit the 49 Degrees North Ski Patrol [a non profit organization] to aid in safety and first aid. The citizen's course will be a climb up through the Sunrise Basin, then a traverse across the face of the mountain, and finally a fun downhill run back to the lodge. There are many great view points, clean mountain air, refreshments, and support services along the way. There will also be an extended and more advanced course, to the summit, for those who are up for a greater challenge. This year, for the first time, riders may start in Chewelah at the park and ride on pavement to the 49 North lodge and from there continue on the routes described above, This will be the Rough Ride 4000. All riders should be prepared for adverse weather and must wear an approved helmet.

In consideration of being allowed to participate in any way in the event, related events and activities, the undersigned acknowledges appreciates and agrees that:

1. I understand bicycle riding and the use of ski are facilities including parking lots, roads, trails, decks, lifts and, buildings involves risk or injury due to causes including but not limited to, loss of control or falling, contact with unexpected trail or road conditions, contact with objects: Variations in terrain, surface or subsurface conditions; rocks, trees, or other forms of forest growth or debris, vehicles, gates, other riders, animals, bystanders, officials. The risk of injury from the activities involved in this event is significant, including the potential for permanent paralysis and death while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and,

With knowledge and appreciation of the risk of injury, I nevertheless desire to enroll myself or my child in the event and expressly assume the risk of myself or my child being injured by participating in the event, knowing for myself or for my child that it is each rider's sole and individual responsibility to know the range of his or her own ability to negotiate any course at all times while riding, to heed all posted warnings, and to refrain from acting in a manner which may cause or contribute to the injury of anyone.

If however I observe any unusual significant hazard during my presence of participation, I will remove myself or my child from participation and bring such to the attention of the nearest official immediately; and,
